SEPTEMBER SELECTED FOR 2002 HOF/SAALE REUNION

Results of the 2002 Hof Reunion Survey reveal the majority of the Hof Reunion Activity membership favors a 2002 Hof/Saale Reunion and will participate or will try to participate. Based upon the information provided in the survey, a 5 day, Hof Reunion will be held in Hof/Saale, September 2002. More details will be provided in the July 2001 Hof Connection Newsletter.

Hof Reunion Survey Data:

1. Definitely will participate in a Hof Reunion held in Hof/Saale.
44 Surveys total: 27 voted Sept. 12 voted July 5 voted May
2. May participate in a Hof Reunion held in Hof/Saale.
79 Surveys total: 51 voted Sept. 13 voted July 15 voted May
3. We will not participate in a Reunion held in Hof/Saale in 2002.
9 Surveys total (No remarks about item 4)
4. Would rather have a reunion in Minneapolis or Orlando in 2002 or 2003.
(Write In = St. Louis, Las Vegas). Many did underline 2003. 61 Surveys Total

Prior to the Colorado Springs banquet, a Hof Reunion had not been discussed or coordinated with Hanns Karl Ritter or Officials from Hof. As a result, we received a couple of very nice letters expressing concern for the possibility of wearing out our welcome with the German public by returning to Hof for a reunion so shortly after the very successful 1998 reunion orchestrated by Hanns Karl and our Deutscher friends listed on the Master Hof Roster. The writer's suggested we defer the 2002 Hof reunion to 2004.

Based upon the above information, I called Hanns Karl Ritter (Chair of the Hof Committee for the 98 event) who had already sent us an email offering his assistance with the 2002 Hof/Saale event. Hanns Karl said, "you will always be welcome to return to Hof for a reunion, however, the participants cannot expect the pomp and ceremony and level of official support provided for the 1998 reunion. That level of official support can never be achieved again, regardless of when you return to Hof for a reunion." Hanns Karl then stated he was under the impression that the majority of people in attendance at the Colorado Springs Reunion voted for Hof/Saale in 2002. I am not certain it was a vote, but with a show of hands, more than 50% did indicate they would participate in a 2002 Hof/Saale Reunion.

We will provide a survey/questionnaire with the July 2001, Hof Connection Newsletter, the membership can select a tentative month and location for the Hof Reunion Activity in 2003. Four cities with superior and reasonably priced air service have been nominated for consideration in 2003. The cities are Orlando, Minneapolis, Saint Louis, and Las Vegas. Each city has its merits. We expect to have an additional 200 paid members and 500 more names and addresses on the "Master Hof

Roster" by July 2001. We are certain some of the new finds will want to participate in this decision making process.

VIRUS ATTACK ON MEMBERSHIP
INTERNET USERS

An Internet Bandit somehow obtained an early September copy of the Master Hof Roster. In December, the NAVIDAD.exe virus was disguised and titled "Hof Master List" emailed to a large number of members using the email address of a person listed on the roster, living in Florida. Soon more attacks were made using the title of "Hof Master Roster" and the email address of a former Hof colleague living in Minnesota. The person in Minnesota claims he downloaded the email sent to him from Florida and it wiped his system program clean. The FBI & AOL have the virus attack under investigation.

As a result of the above incident, we have taken the following measures. The only email addresses authorized to send Hof Reunion Activity official messages are

>**HofReunion@aol.com**< and >**Cwilson940@aol.com**<.

We will also place our names or initials in the first sentence of the message in an effort to let members know the email is legitiment.

As producers of the "Master Hof Roster" we hold proprietary rights and have not authorized and will not authorize any modification or changes to be made to the Hof Master Roster.

Please **DO NOT download** attachments from email addresses you do not recognize. We suggest you "**Delete**" any "**Hof**" messages you receive that are not from "HofReunion@aol.com or Cwilson940@aol.com.
